COVID/SUPPLIERS

I understand that Dream Gyrl Travel, LLC is not the source or supplier of the travel services I have requested, and acts solely as an agent for the actual suppliers of such services. I have been advised that the suppliers whose names appear in the information supplied to me are those who are actually responsible for providing the travel services I have purchased. I have been advised to use a credit card as this may offer me the opportunity to dispute the charge should a vendor cease operating.

I understand that the Transportation Security Administration (TSA) requires me to carry a government-issued identification card in order to board a flight. I have been advised that the name, date of birth, and gender that appear on the identification card must exactly match the same such data that is listed on my airline ticket and in my booking records. I acknowledge that my failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing me to miss my flight.

I understand that if traveling internationally, it is the "Traveler/Clients" responsibility to have a valid passport, visa required for entry and departure for each country or region. This also includes any vaccinations, certificates or insurance policies. I may need to obtain one or more visas which is the client's responsibility to obtain before the trip begins. "Travel/Client" must have a passport that is valid 6 months after the last date of travel (see passport requirements)

The "Traveler/Clients agree to be responsible for the full amount of any loss or expense as a direct result of "Travel/Client failure to secure or possess the proper travel document/s prior to the trip dates.

Non-U.S. passport holders should be sure to contact the embassies of their destination and transit countries to obtain entrance requirements. I understand that the airline tickets, air tours, or other products I am purchasing are subject to supplemental price increases that may be imposed after the date of purchase.
